Dear SVM Colleagues,



I hope everyone is vaccinated and is looking forward to a much better summer this year. I can't wait to get out more and enjoy small graduation parties and attend a good 4th of July celebration. I can't believe that this is my last President's message.

I want to start with some great news – We have a new management company! Let me back up a bit. In early fall 2020, the SVM Board

of Trustees reached a unanimous decision to initiate a search for a new association management company (AMC). Kellen Company had been SVM's AMC since 2007. While the decision was difficult, it was essential and took months of deliberation. SVM needs a partner that shares our long-term vision, serves our members and committee volunteers, and guides our officers with fiduciary and administrative responsibilities. As an immediate first step, the leadership created an SVM Taskforce to assist with the AMC replacement. This task force consisted of Drs. Mark Creager, James Froehlich, Elizabeth Ratchford, Herb Aronow, Esther Kim, and I. We hired a consultant – an AMC expert (Mr. Terrance Barkan) and an attorney to help us navigate the complex process. Over the past six months, we mapped our transition, and most importantly, secured our finances; we then sought RFPs from AMCs and conducted interviews. The Board of Trustees ultimately voted to select **Veritas Association Management** as our new AMC, as recommended by the Task Force.

After a month of transition time with Kellen, Veritas took over SVM's management from April 26th, 2021. Veritas shares our values, and I am confident that this partnership will help SVM advance in the right direction. The leadership is highly optimistic, and we have already noted a significant improvement in customer service. We welcome Veritas to our SVM team.





THE NHLBI SPONSORED C-TRACT TRIAL

Patients with post-thrombotic syndrome (PTS) and iliac vein obstruction suffer from severe limb symptoms and poor quality of life. The National Institutes of Health funded C-TRACT (Chronic Venous Thrombosis: Relief with Adjunctive Catheter-Directed Therapy) trial is being performed to evaluate if venous stent placement can improve symptoms safely and durably. All study patients receive close monitoring and outstanding multi-modality PTS care that includes medical therapy, compression garments (usually provided by the study), and venous ulcer care.
