Board Certification – SVM continues to work on your behalf in pursuit of Vascular Medicine board certification. We are in the process of securing letters of support from various US and international cardiovascular societies for our ABIM application. At this time, no decisions have been made about certification pathways (e.g., internal medicine => vascular medicine; cardiovascular medicine => vascular medicine; or a dual pathway that allows for both approaches). We will solicit input from SVM membership before any decisions about certification pathway are made. Please stay tuned!

EDUCATION

The Vascular Scientific Sessions - President-Elect and Program Chair, Ido Weinberg, the SVM Scientific Program Committee, and our partners at Veritas Association Management worked diligently to create and deploy the 2022 Vascular Scientific Sessions in Denver, Colorado. The meeting was a resounding success and included new and reimagined sessions including a hands-on

POCUS workshop, a risk-factor management workshop, Late Breaking Science, and even an inaugural SVM 5K Fun Run in memory of Dr. William R. Hiatt. We also hosted 25 primary care and hospital medicine physicians at the Updates in Vascular Disease primary care track presented by SVM faculty who shared up-to-the-minute, state-of-the-art knowledge in vascular disease diagnosis and management. Finally, the Jay D. Coffman Young Investigator Award for the top basic, translational, or clinical research submission to the Vascular Scientific Sessions was bestowed upon Omar Chehab, MD, MSc, Johns Hopkins School of Medicine, Baltimore, Maryland, for his study, *"Association of HIV Infection with Clinical Features and Outcomes of Patients with Aortic Aneurysms."*

QUALITY

SVM continues to push the needle on quality improvement. In a collaborative effort with the Society for Vascular Surgery Patient Safety Organization (SVS PSO) and the American Heart Association, past President Josh Beckman helped design the Vascular Quality Initiative's <u>Vascular Medicine</u>

Consult Registry (VMCR), which follows ambulatory patients with vascular disease. The VMC Registry adds tremendous value to the portfolio of available VQI registry modules and provides an incredible opportunity for SVM members who practice at participating institutions to engage in meaningful research and quality improvement initiatives. RESEARCH

The SVM Research, Quality, and Publications Committee, led by Chair Daniella Kadian-Dodov, MD, has two papers in progress. A vascular medicine white paper is a joint effort of SVM and the European Society of Vascular Medicine and is currently being outlined. The Committee is also working on *Research Priorities in Vascular Medicine*, an effort being co-chaired by Dr. Marc Bonaca and Dr. Mary McDermott.
